Beyond Blindness is a one-stop support resource for these children, and their families, and provides services in clients' homes, at its location in Santa Ana, and in schools throughout Orange County.

## **Position Summary:**

The Early Intervention Specialist position conducts developmental skills assessments, provides individualized reports for each child and their family, assesses child and family needs, provides resource and referral services, and consults with a variety of community agencies and professionals for in-home clients and their families. This specialist serves students and families in the home and/or on the Beyond Blindness site.

This job description is intended as a guide to the general job responsibilities.

### **Responsibilities Include:**

- Provides in-home clients and their families with quality developmental services.
- Maintains regular communication with supervisor.
- Participates in Individualized Family Service Plan and Individualized Educational Plan transition meetings.
- Develops and updates individual outcomes for infants and their families through progress evaluations and written reports.
- Awareness of and know how to access community resources.
- Participates in training and meetings.
- Maintain toys and educational supplies.
- Maintains daily records and billing information.
- Represents client interest and shares authorized information with coordinating agencies.
- Treats clients, families and others with empathy and respect and conducts self in a professional manner.
- Establishes and maintains interpersonal relationships with teammates, community organizations, supervisors, and leadership.
- Complies with organizational guidelines and HIPAA.
- Promotes and conducts parent tours.

## **Licensing & Accreditation Requirements:**

- 1. LiveScan Fingerprint clearance and background check DOJ/FBI/Child Abuse Index (one time or upon rehire)
- 2 Health Screening (one time or upon re-hire)
- 3. Proof of immunity to Measles or MMR Vaccination Record (one time)
- 4. Flu Vaccine within one year (and each year thereafter)
- 5. TDAP Vaccine within last 10 years (and every 10 years thereafter)
- 6. Current COVID-19 Vaccine (Preferred)
- 7. Clear TB test or Chest X-ray within last 4 years (and every 4 years thereafter)
- 8. Current up-to-date Credential, License, Certification or Units for employment
